GUIDELINES

- Entering this exhibition shall constitute understanding and agreement on the part of the artist with the conditions stated.
- Drawings, paintings, original prints on paper (not reproduced artwork, i.e. giclée) are eligible.
- All work must be created and conceived by the artist. No photography, computer generated art, other media is accepted and encouraged, both 2D and 3D. Sculpture entries may include up to 3 views of the same piece.
- Figurative work including nudes are acceptable.
- Works previously exhibited in a MSPP show are acceptable.
- Only digital entry submissions will be accepted.
- Images should only be of the artwork. DO NOT include matting, frame, etc. in the image.

COMMISSION

- Artist will receive 73% of sales price for any artwork sold. CCAC retains 27%.
- All work must have sale price indicated. Not for Sale is acceptable. POR (Price on Request) is **NOT** acceptable.

FRAMING

The Artist/Exhibitor must have all works of art appropriately framed and ready for hanging, or otherwise prepared for installation. MSPP reserves the right to refuse unacceptable frames, i.e., wood strips, lack of wires or hooks on the back to accommodate the gallery's hanging system.

The CCAC reserves the right to refuse to allow installation of any work, which in its discretion, is not suitable for hanging, or installation. Any pieces of unusual size, weight, or installation characteristics will be reviewed by the MSPP with the Education and Visual Arts Coordinator at least three weeks prior to the show.

DURATION OF EXHIBITION

All works of art must remain on display in the Gallery until the closing date of the exhibition. All unsold works are to be picked up by the Artist/Exhibitor on September 2.

LIABILITY

The Arts Center is staffed at all times, and utmost care is taken in handling the art, monitoring the building and visitors. However, CCAC strongly encourage all artists to maintain insurance on their works. The CCAC is not responsible for loss due to shoplifting or damages.

DELIVERY & RETURN

Work must be picked up from CCAC on September 2 (12-7pm).
